The United Way Allocations Committee provides the vital service of monitoring the distribution of funds to United Way's partner agencies. The committee meets with representatives from each agency, reviews the amount requested, carefully scrutinizes financial records and programs, and makes sure each program meets a critical need.

This process takes place over several meetings each Spring and culminates with recommendations to the United Way Board regarding the amount of support allotted to each agency for the coming year. The final decisions are made in May. As the year progresses, the agencies file reports regarding expenditures and progress made in meeting goals and objectives.

Christmas is supposed to be a time of family, good will, and good tidings, it seems unfair when something traumatic happens to someone around the holidays. The day after Christmas in 2015, Family Services of North Alabama - a United Way Partner Agency received a call indicating a sexual assault had occurred in Marshall County. The victim went to the ER and called law enforcement, a situation that triggers a response from FSNA's Sexual Assault Support Services Program (SASS) and Sexual Assault Nurse Examiner Program (SANE). The SANE nurse and a SASS victim's advocate met Mrs. Kelley\*, an 80-year-old lady that had been sexually assaulted by an unknown perpetrator. The SANE nurse conducted a full sexual assault kit to gather evidence for law enforcement, while the victim advocate provided emotional support to Mrs. Kelley.

While the immediate response is a major part of the services provided by FSNA's programs, the SASS program extends beyond helping the victim in the immediate aftermath of an incident. Round the clock support is offered to family and secondary victims for however long is necessary to help all those affected cope with the effects of such traumatic events.

In Mrs. Kelley's case, SASS victim advocates kept her updated on the status of her case, would visit her several times a month, accompanied her to church when she felt too nervous to leave her home, and brought her lunch and other small gifts to lift her spirits.

Mrs. Kelley struggled with hearing loss, but she lives on a fixed income and lacked the resources and finances to afford hearing aids. Her victim advocate took notice and sought out the advice and assistance of **2-1-1 First Call for Help** Resource Specialist, Mrs. Pat Potts.

Mrs. Pat Potts wasted no time in finding and referring the FSNA staff to the Starkey Hear Now Program, provided them with an application for that program, found a local authorized hearing professional, and explained how the advocate could assist Mrs. Kelley in applying for hearing aids.

In 2016, Mrs. Kelley was approved to get brand new hearing aids. She was thrilled and grateful for the support Mrs. Pat Potts and the FSNA staff provided. Although her victim advocate sometimes slips up and speaks loudly, Mrs. Kelley proudly reminds her that she can hear perfectly now thanks to the help and resources provided by 2-1-1 of Marshall County.

Fast-forward to 2017, the perpetrator was charged and pleaded guilty to first-degree rape and attempted first-degree rape. He will serve 30 years in prison.

'Til this day, FSNA advocates check in on Mrs. Kelley from time to time to make sure everything is going well. Mrs. Kelley also likes to pop up by their office sometimes to show her deep appreciation to the staff.

# 2-1-1 First Call for Help

In 2018, the 2-1-1 call center received a total of 2,146 calls with the number one request being assistance with utility bills. The First Call for Help program housed in the United Way of Marshall County office answered 1,014 of these calls. The call center is an information-based center for people with need of non-profit help or social services. Call Center specialists are trained to answer a wide variety of questions. 2-1-1 also provides United Way with statistical information regarding the needs of individuals in Marshall County. County statistic reports show that our callers most needed services were:

UTILITY ASSISTANCE, HOMELESS SHELTERS, TRANSPORTATION, FOOD, PRESCRIPTIONS AND RENT.

Working with the national organization Familywize, United Way/2-1-1 has been able to provide prescription assistance cards to individuals in Marshall County. The cards can be used at most local pharmacies to provide significant savings on medications for those who currently have no insurance or low prescription coverage.

In 2018, Familywize cards saved residents in Marshall County \$259,049 in prescription costs and helped a total of 3,859 individuals.

Since 2007, Familywize cards have helped saved residents \$1.7 million in prescription costs.

Emergency Food and Shelter Program (EFSP) was created in 1983 to supplement and expand the work of local social service agencies, both nonprofit and governmental, to help people with economic emergencies (not disaster - related). United Way of Marshall County leads the local board for Marshall County, charged with soliciting grant requests and then determining the highest need and best use of funds.

In 2018, a total of \$40,427 were awarded to six local programs in Marshall County through Phase 35 of this program.

EFSP funds are used to provide the following assistance:

Food via served meals or groceries | Shelter via mass shelter, off site lodging or rent/mortgage assistance | Utilities via limited metered and non-metered assistance

# WHERE THERE'S HELP, THERE'S HOPE

Mr. Wilson\*, a disabled, 13 year Army Veteran suddenly found himself struggling to make ends meet, as his disability check had been mistakenly stopped. He had nowhere to turn and found himself in a situation that seemed hopeless. "I found myself with no money... with no means of paying my bills," stated Mr. Wilson.

It was then that he decided to contact 2-1-1 First Call for Help. Mrs. Pat Potts, our resource specialist, was able to find the resources needed to help Mr. Wilson through this hard, unexpected situation. "Mrs. Potts and her keen guidance assured me that all [would] be fine," said Mr. Wilson, "I appreciate the funders of United Way from the deepest part of my soul."

# WHAT IS UNITED WAY?

United Way of Marshall County is a local, independent non-profit organization that has served our community for over 20 years while delivering a high return to the community with low cost. United Way identifies issues facing our community's residents, and we seek solutions to those problems. We provide funding to local agencies and programs that work tirelessly to improve lives and positively impact Marshall County.



### HOW MUCH MONEY IS DISTRIBUTED BY UNITED WAY?

In 2018, United Way of Marshall County invested \$523,114 into our community through our 22 partner agencies and programs and special grants and designations. We do not disperse funds directly to individuals. All funds distributed are sent directly to our agency partners and programs to handle the direct assistance to individuals in need.



# WHERE DOES MY MONEY GO WHEN I GIVE TO UNITED WAY?

United Way is one of the most local of all national charities in terms of its governing body and operations.

99% of the funds raised in Marshall County stay in our county. The remaining 1% of funds is sent to United Way Worldwide to maintain our membership and gain access to branding, market research and training.



#### HOW ARE THE FUNDS ALLOCATED?

Non-profit organizations must submit a detailed application for funding each year, and the application is reviewed by a group of community volunteers. In addition to an application, site visits are conducted. Each applicant must make a presentation to the Allocations Committee and answer questions about their organizations. Funding decisions are not made by the United Way
