It was a defining moment in 1993 when United Way of Marshall County was officially incorporated, heralding the beginning of an extraordinary chapter in the county's history. Over the past three decades, United Way has emerged as a beacon of hope, igniting a collective spirit of resilience, innovation, and unity that has transcended boundaries and brought people together.

Before the establishment of United Way, the cities of Marshall County operated under separate local service boards, each with noble intentions but limited impact. Recognizing the power of a unified effort, the community realized that true transformation could only be achieved through collaboration. Thus, United Way came into existence, becoming a catalyst for change and a force that would shape the future of Marshall County.

United Way of Marshall County owes its success to a dedicated team, passionate volunteers, and the loyal support of the community. As the organization celebrated its 30th anniversary in 2023, the magnitude of its impact on the community is immeasurable. Countless lives have been touched, dreams nurtured, and barriers broken down, thanks to the relentless efforts of United Way.

Central to United Way's mission has been its tireless dedication to addressing critical needs within Marshall County. The annual fundraising campaigns have been instrumental in allocating resources to areas where they are most needed. We have been able to fund crucial initiatives that combat poverty, promote financial stability, and enhance the overall well-being of the community, thanks to the generosity of donors, both large and small.

As United Way commemorates three decades of remarkable achievements, its focus remains steadfastly fixed on the future. Guided by optimism, the organization continues its pursuit of a community where everyone has the opportunity to thrive. United Way embraces the evolving needs of an ever-changing society, seeking innovative solutions and fostering collaborations to create a brighter future for all.

Reflecting on the journey, it is evident that United Way of Marshall County has come a long way since its inception. In 1991, meetings began to consolidate the Albertville, Arab, Boaz, and Guntersville United Ways into a single, unified entity. By April 1993, the articles of incorporation and by-laws were filed, paving the way for a united front. The inaugural countywide campaign commenced in October of the same year, raising an impressive \$592,000—a substantial increase from the \$340,000 raised during the last year of separate campaigns.

Over the years, United Way's impact has grown exponentially. The establishment of First Call for Help, a centralized Information and Referral service in August 1995, provided crucial assistance to individuals seeking support in everyday needs and times of crisis. In June 2006, United Way of Marshall County became a 2-1-1 Connects Alabama call center, offering an easily accessible, free-to-the-user phone number for comprehensive human service information and referrals. Today, the organization receives approximately 125 calls per month, underscoring the vital role it plays in the community.

Throughout its history, United Way of Marshall County has remained steadfast in bringing the community together to address the most critical needs. Its dedication to funding programs based on identified community needs has resulted in continuous growth, allowing agencies and programs to expand their services to the citizens of the county.

As United Way of Marshall County looks to the future, the organization remains poised to make an even greater impact. With an unyielding belief in the power of collective action and an optimistic outlook, United Way stands ready to forge ahead, seeking new opportunities, fostering collaborations, and embracing the evolving needs of the community it serves. The 30th anniversary celebration is not just a commemoration of past achievements but also a testament to the boundless possibilities that lie ahead as United Way continues its journey towards building a thriving, inclusive, and resilient Marshall County.



United Way's partner agency Court Appointed Juvenile Advocates was appointed to the case of an eight-year-old boy named "Tommy". Both of his parents were deep into drug addiction and did not have custody of any of their five children. Tommy was placed with his uncle when he was five years old. It was discovered years later that his uncle had several "indicated" reports of sexual abuse with other family members, so Tommy was removed from his uncle's home and placed in foster care.

When Tommy first entered foster care, the foster parents reported that he did not know how to do much on his own. He could not dress himself or clean himself in the bathroom, he didn't like to brush his teeth, and complained about how much his mouth hurt. After visits with healthcare providers, it was discovered that he had 12 cavities and an infected rash all over his body.

The foster parents reported that Tommy had angry fits where he could not seem to control his anger. The CAJA volunteer pushed for Tommy to receive counseling and it was arranged for Tommy to work with a therapist and the therapist came to work with him at school during the school day on the anger management issues.

The CAJA volunteer reached out to Tommy's previous school that he attended while living with his uncle. According to the school staff, Tommy arrived in kindergarten with limited speech. Due to an excessive amount of tardies and absences from school, Tommy did not meet the kindergarten standards and was required to repeat it.

Once Tommy was placed in foster care, his school work improved, but his behaviors did not. Tommy was moved to three different foster homes. The CAJA volunteer visited him often and stayed in constant contact with DHR and the foster parents to help the transition to each new foster home.

Tommy's uncle filed for custody of Tommy, but the CAJA volunteer had many concerns with the uncle and his home. The CAJA volunteer shared the many concerns with Tommy's GAL (his attorney), his DHR case worker, and detailed the concerns in

The CAJA reports. Relative placement is preferred over foster care, but in this case the CAJA volunteer felt this was not an appropriate placement for Tommy.

The custody case for Tommy lasted over a year, but the CAJA volunteer was there for him throughout the process. The CAJA volunteer formed a bond with Tommy. Tommy shared that he really wanted a family. The CAJA volunteer was in contact with Tommy's new school and monitoring his needs and progress. The CAJA volunteer pushed for Tommy to receive speech and occupational therapy to help him "catch up" with his classmates. The CAJA volunteer attended every court hearing and ISP for Tommy and updated everyone on his progress. The last foster home Tommy was placed in seemed to be a good fit for him and the family.

The court denied the uncle's petition for custody, due in large part to the CAJA volunteer's testimony and court report. Tommy was adopted by his current foster home. The day of the adoption, the school reported Tommy ran down the hall shouting "I'm going to be adopted! I'm going to get to stay with my family!".



EMERGENCY FOOD AND SHELTER PROGRAM

Emergency Food and Shelter Program (EFSP) was created in 1983 to supplement and expand the work of local social service agencies, both nonprofit and governmental, to help people with economic emergencies (not disaster - related).

United Way of Marshall County leads the local board for Marshall County, charged with soliciting grant requests and then determining the highest need and best use of funds.

In 2023, a total of **\$19,090** was awarded in Marshall County through Phase 41 of this program.

EFSP funds are used to provide the following assistance:

- Food via served meals or groceries
- Shelter via mass shelter off site lodging or rent/mortgage assistance
- Utilities via limited metered and non-metered assistance


